#### 1. What are the after-school rooms?

After-school rooms provide places for play and live for elementary school children, who will be alone at home after school as their parents/guardians are, for example, working or are in the hospital due to diseases, aiming for their mental and physical healthy growth.

#### 2. Operating hours / Closed days

#### 4. Eligible children

Elementary school children who live in Funabashi as of the first date of the month they wish to enroll in the room, and will be left alone after school because their parents/guardians are in the following situations:

\*The children cannot be admitted to an after-school room if they live in the same address as their grandparents' who are under the age of 65 (including the case living in another building in the same address, the case not sharing the living expenses) unless the grandparents have the same reason(s) as parents/guardians.

(You need to submit their certificate(s) of employment, medical certificate(s), etc.).

- \*As for sending by postal mail, they have to reach us by the deadline, as for online and bringing-in, it's 5:00 p.m. on the deadline date.
- X1 As for the second application, additional screening will be conducted only for rooms with available capacity after the screening of the first application.
- X2 The second application deadline for school children with disabilities, children with developmental and growth concerns, and children require medical care is February 16 (Monday), 2026 [As for sending by postal mail, they have to reach us by the deadline, as for online and bringing-in, it's 5:00 p.m. on the deadline date].
- 3 Regarding the application after May 2026, please read p. 8.

#### 6. Children who need support at an after-school room

For children with disabilities, children with developmental and growth concerns or children require medical care, we will conduct <u>a telephone interview and a trial enrollment</u> before enrolling in a school to judge their necessity of support as well as whether they will be allowed to enroll in or not.

If you make an application, please call the Child Rearing Support Section beforehand and make an appointment for the interview.

- \*After-school rooms do not have any function as therapeutic education facilities.
- If any mental or physical disability, etc. is found after the enrollment, we will carry out a telephone interview and a trial enrollment again and judge their necessity of support as well as whether they will be allowed to enroll in or not.
- If you have any possibility of school transfer, please be sure to contact the Child Rearing Support Section (by January 9, 2026).

#### 7. Snacks

We provide snacks at after-school rooms. The menu is the same for all the rooms.

Yet, for children with allergies, we have dedicated menus that exclude eight specified allergenic ingredients. Also, if you have any circumstances, you can bring your own snacks instead of receiving ours. In this case, please submit "Notification of Change in Enrollment Matters (Cancellation of Snacks, Resuming, and Changing Menu)."

If you don't receive snacks, we will deduct the snack fee (2,000 yen) from the after-school care fee.

If you want to partially remove snacks due to allergies or diseases, please submit "Removal Request for Snacks."

#### 8. After-school care fee

- The after-school care fee (usage fee) is 10,000 yen per month (including fee for snacks). \*There is a reduction or exemption system.
- · As a rule, please pay the fee by automatic account transfer.

Please make the procedure at your earliest convenience when you received an "Unofficial Offer of Admission" together with an "Account Transfer Request Form."

XIt takes about two months to complete the automatic account transfer procedure after applicationX

Until the month the transfer starts, please settle the payment using a "payment slip" at a financial institution or at a convenience store and so on listed on the backside of the slip which will be postal mailed from the city together with a "letter of acceptance."

#### 《Automatic account transfer》

Please fill out the account transfer request form and submit it to the financial institution where you wish to make the automatic transfer or to the after-school room your child attends. Check the available financial institutions by scanning the two-dimensional barcode on the right.



After completing the procedure for account transfer, we will send you a Japanese text only "Notice of Account Transfer Payment" by postal mail.

Please make a payment using a "payment slip" until the account transfer starts.

#### (Online account transfer application)

There are some cases you can apply for account transfer online.

For details, please search by "Online account transfer application" on the website of Funabashi City, or check the two-dimensional barcode on the right. You can apply for it even before admission is granted.



Also, if you cannot enroll in April, the account transfer does not start while you are waiting for the admission to be granted.

#### 《Payment methods other than account transfer》

#### · by payment slip

A payment slip will be postal mailed to you with the letter of acceptance in the middle of April.

Please use a financial institution or a convenience store written on the backside of the payment slip.

(Available payment locations are subject to change).

#### by smartphone payment app

You can make a payment at home by scanning the barcode on the payment slip using the in-app camera of a compatible smartphone payment app.

As for the payment procedure and points to be noted, please search the city website or check by scanning the two-dimensional barcode on the right.

- Payment deadline for the after-school care fee is the end of the month you used the room (as for December, the date is 25). If the date falls on a Saturday, Sunday or holiday, it will be the next business day of the financial institution.

- Please note that if after-school care fee was not paid by the deadline, <u>a</u> <u>delinquency fee can be</u> <u>imposed on.</u>

#### 9. A reduction or exemption of after-school care fee

There are some cases after-school care fee can be reduced or exempted depending on the income situation or the enrollment condition such as simultaneous enrollment of siblings. For detailed information and necessary documents for application, please read the sheet (green) titled "A Reduction or Exemption of After-school Care Fee." Please keep in mind the followings if you apply for it.

- (1) Please submit all the necessary documents for the reduction or exemption no later than the deadline. If you lack documents or miss the deadline, the reduction or exemption will not be made until all the documents are submitted. (We will judge whether the reduction or exemption dating back to your admission month is possible only if all the documents are submitted by the end of the fiscal year 2026).
- (2) If you are anxious whether your documents were delivered or not, please contact us. Please keep in mind that municipal office will not contact you from our side.

#### 11. Admission Decision

Admission is granted not by application order but by examining the employment situations, etc. of parents/guardians based on the submitted required documents (such as a certificate of employment) to confirm the admission requirements.

If you did not submit the necessary documents by the application deadline, you will not be admitted in the month you wish as we cannot conduct admission screening.

Also, please keep in mind if the number of applicants exceeds the capacity, you may not be able to enroll in even if required documents have been submitted.

To those who applied during the first application period and wish for the enrollment from April 1, 2026, we will individually inform the likelihood of acceptance (by postal mail) around the end of February, 2026.

\*To those who applied during the second application period, we will inform them around the end of March.

#### 12. Others

#### (1) Application during a childcare leave or job searching

You can apply for admission to an after-school room during a childcare leave or job searching.

However, applications for other reasons are given priority, so if there are no available capacity, you will not be able to enroll in.

If you are on your childcare leave, you need to submit a "certificate of employment written the period of childcare leave" when you make an application.

In case of enrolling in while your seeking employment (including the case you applied for due to your employment situations and got unofficially admitted, but retired from your work before enrollment), you need to submit a "certificate of employment" (for the position starting by May 2026) by April 15 (Wednesday), 2026. (Though online submission is possible, the deadline is 7:00 p.m. on the same date). If you did not submit the document, you have to leave the room at the end of April, 2026.

## (2) If you do not have a resident registration in Funabashi city when making an application

You can make an application if you complete a resident registration by March 31 (Tuesday), 2026 (being a Funabashi citizen as of April 1).

#### (3) Admission during spring, summer and winter vacation

During the school vacation, you can apply for a room even if parents/guardians work ends before 2:00 p.m. as for the admission requirements. However there are some cases you cannot enroll in depending on the enrollment status. The enrollment date is every 1st of the month.

As for the application deadline, please refer to "13. Application for admission after May, 2026"

However, please note if you wish for an admission during the period of spring vacation in April, 2026, the application period is as written on page 1.

#### (4) Cancellation of admission

If any of the following cases applies to you, your admission will be cancelled.

- 1 If the admission requirements such as employment situations do not meet the conditions any more
- 2 If there is a delinquent payment for the after-school care fee without good reasons
- 3 If mayor judges the child is not suitable for the group life

#### 13. Application for admission after May, 2026

The deadline for the application is 15th of the previous month you wish for admission (if it falls on a Saturday, Sunday or national holiday, it will be the following date, etc.).

For school children with disabilities, with growth and development concerns or who need medical care, the application deadline is 15th of the month before last you wish for admission. (For details, please refer to "6. Children who need support at an after-school room" on p. 2).

#### XThe deadline for all the online applications is 5:00 p.m. on the same date, too.

# Admission screening From the following date of the application deadline

#### Result

- If your application is accepted, we will send you a letter of acceptance by postal mail around 20th.
- If you are not accepted, we will call you within a few days after the admission screening.

### Admission (those who received an unofficial offer of admission)

- You can use the room from the 1st of your admission month (except for closed days).
- You will receive documents such as a payment slip for the fee in the early month of your admission.



#### (If your admission is officially approved)

- We will hold a guidance for enrollment starting from the following month.
- Please call the after-school room you will enroll in to confirm the schedule.

• If your admission is not approved, we will notify you about the outcome of your first application only. After that, we will keep your documents and if there is available capacity in the room you wish to enroll in, we will rescreen and contact you only if you are accepted.

Your application documents will be valid till the admission of March, 2027 and will be eligible for admission screening.

\*If you cancel your application after having been approved, please contact the Child Rearing Support Section by the end of the previous month of your enrollment. If there was no report regarding cancellation, your admission is finalized and after-school care fee will be incurred.
